All movement regardless of Empty or Laden containers was sending thru EDI scheduled transmission, container movement will be created automatically according to data received either it is CODECO or COARRI. Assuming that all data is transmitted to us in time and no errors, there should be no need for us to manually input the movement data in Option.#3011 anymore. Double entry would only resul in EDI errors.

Manual input is an easy way to solve movement issues quickly, but we should always try to use resolve EDI problems to reduce repeated work. Instead always use and check Option.#3811 to track and control EDI from BHR and SYN.

Option.#3052 is for checking container history. When dealing with EDI matters, please always check #3811 instead cancel and input from Option. #3011.
