

# **PARTNERSHIP AGREEMENT**

### 1. PARTIES OF THE AGREEMENT

Between,

**Mr. Sérgio Barbosa Dias Leite,** with Passport no CA095580 from Portugal, FPF Registered Intermediary, acting on behalf and in representation, as the CEO and owner of the company **SLWORLDTEAM**, with VAT 51178570, located at Rua Dr. Carlos Pires de Felgueiras no 173 60 A, 4470-157 Maia – Portugal. And

**Mr. Awad Ahmed Mustfa Nazar**, of legal age, holder of Passport number PAS PO2349071 from Sudan, acting in his capacity as an Intermediary in Saudi Arabia, on behalf of SLWORLDTEAM.

# 2 . OBJECT OF THE MANDATE AND EXCLUSIVITY

- a) Mr. Sérgio Barbosa Dias Leite and Mr. Awad Ahmed Mustfa Nazar, will cooperate and work together as a partnership in Saudi Arabia regarding transfers of players and coaches.
- b) By this agreement, Mr. Sérgio Barbosa Dias Leite authorizes Mr. Awad Ahmed Mustfa Nazar to undertake preparatory talks, negotiations and all other dispositions required to sign a work contract for players represented by Sérgio Leite, SLWORLDTEAM, or any other representatives (authorized clubs) in footballs clubs from Saudi Arabia leagues.



- c) Mr. Awad Ahmed Mustfa Nazar, undertakes to represent Mr. Sérgio Leite and SLWORLDTEAM, by negotiating, pre-signing or signing any type of Work/Image Rights/Representation Contract at Saudi Arabia Clubs.
- **d) Mr. Awad Ahmed Mustfa Nazar,** will <u>work in exclusivity</u> with SLWORLDTEAM.

# 3. TERM

The term of this agreement shall take effect on 1<sup>st</sup> January 2018 and terminate on 15<sup>th</sup> February 2023 and will be automatically renew if any part renounce within 60 days prior to the end.

# 4. REMUNERATION/FEE

Mr. Sérgio Barbosa Dias Leite and Mr. Awad Ahmed Mustfa Nazar, agreed to share any remuneration fee or incoming remuneration in equal parts.

### **5. ENTIRE AGREEMENT & TERMINATION**

This Agreement its irrevocable, may be amended, modified, superseded but never terminate, only if both parties expressly agree to do it in writing.

#### 6. LEGISLATION AND DISPUTE RESOLUTION

The Parties agree to adhere to Portugal and courts law provisions.

All disputes arising in connection with this Agreement, including disputes concerning its existence and validity, will be settled in the first instance by the competent courts in the area in which Mr. Sérgio Barbosa Dias Leite is domiciled.

The language of the procedure shall be English.



This Agreement was made in Maia (Portugal), in English and may be signed by the Parties from different locations and both parties agreed to not notarize signatures.

Passport Copies of both parties will be attached to this Agreement.
